Saint Andrew's Court and **Harvest Commons** provide Single Room Occupancy (SRO) apartments to men and women who have successfully completed the Saint Leonard's House and Grace House programs. These permanent supportive housing programs provide continued care to residents in the next stage of the reentry process. In addition to case management, residents also have access to individual and group counseling, medical and dental referrals, cognitive behavioral therapies, substance use treatment, relapse prevention, and life skills groups.

71 tenants were safely housed 36 tenants found and maintained employment 12 tenants moved into permanent housing

The Barlow Center offers education and employment services to reentering citizens in the community. These services includes the Road to Success job readiness preparation program, Construction Skills and Culinary Skills Training Programs, the adult high school completion program, financial literacy, computer literacy, one-on-one employment counseling, and job placement services. Barlow Center services empower individuals to gain the skills and confidence to reenter the workforce and become self-sufficient.


